It is recognised that this approach remains vital to the Wallcoverings' continued growth and survival in both domestic and world markets.

Our commitment to quality, occupational health and safety and the environment is delivered by adopting an integrated approach to our management systems, our promise is to inspire our customers, make working with us easy and deliver solutions that enhance their project and add value to their business, whilst continuing to invest in our skill base, developing better processes, communication, commitment of personnel and supplier relationships and comply with all relevant legislation, regulations and other legal and industry requirements.

- Newmor Wallcoverings will give preference to FSC certified sources and will actively work to monitor the certification of our suppliers;
- Monitoring the service we provide to our customers through feedback and audits;
- Ensuring health and safety, environmental and quality objectives and targets are set annually and reviewed regularly;
